1. Welcome

The Bishop opened the meeting with prayer and welcomed the members of Diocesan Council, thanking all council members and staff for taking time to be part of this important work in the Diocese of British Columbia. Bishop Logan thanked the members of St. Philipby-the-sea for use of their facility for today's meeting.

Tony Davis, representing the parish, welcomed Diocesan Council to St. Philip-by-the-sea.

The Bishop introduced Barry Foster to Diocesan Council in his role as Executive Officer for the Diocese.

Bishop McMenamie outlined his own activities at the recent House of Bishops. His comments touched on the forthcoming election process for a new Primate. He also described the five (5) options discussed by the House of Bishops for the Marriage Canon to be placed before the General Synod 2019. No statement was issued by the House at the meeting's conclusion.

Vision Reflection on a Season of Discipleship – Bishop Logan McMenamie

Using the passage of scripture, Luke 10:1-9, the Bishop led Diocesan Council in a study of the Marks of Discipleship. Citing author, Parker Palmer, the Bishop spoke about the concept of growing disciples vs. making disciples. He drew the comparison between the western concept of "making a baby" compared to the eastern concept of "growing a baby" and how we speak about our interpretation of the Marks of Discipleship. Table discussion groups were asked to note the traits of discipleship found in Luke 10:1-9. Bishop Logan asked the council to consider what "shapes our membership" within our individual parishes. He shared the following - prayer and sacrament, study, sacred and secular interaction, meeting people and learning, managing the Household of God, simplicity and humility, living and practicing justice, understanding the place of Holy Work, living in harmony with Creation, Anan Cara, conflict as a learning tool, seeing no one from a human point of view, and being an ambassador for Christ, as being things that shape us for discipleship.

Bishop McMenamie concluded his remarks stating that as disciples of Christ, we "journey together and learn from one another and with those [we] meet, enabling [us] to grow disciples."

c) The Chancellor spoke briefly about the work done during the recent National Chancellors' Conference. The Chancellor thanked the council for providing him the opportunity to attend this meeting. A copy of The Chancellor's report is attached to the minutes for January 26, 2019.

3. Living the Vision #1

a) Transforming Futures Facilitator

Bishop McMenamie informed Diocesan Council that Michael Wimmer has stepped down as facilitator for the Transforming Futures initiative. He will stay on in a supporting capacity, as the initiative moves forward.

b) Goals of Transforming Futures

The Bishop indicated to Diocesan Council that Transforming Futures will mean an influx of funds for the congregational development and stewardship for the Diocese of British Columbia. "This is an amazing opportunity for the Diocese ... We are not a dying organization, but I say to you, there is resurrection and we need to live out what that means," said the Bishop.

Executive Officer Barry Foster spoke briefly about a staged roll-out of the program and asked council to consider "what is our local expression of the Diocesan Vision?" He went on to say, "within the parish, talk about the why, the dream and the vision of Transforming Futures." In his past experience, many parishes find that they often will exceed the targets they have set for themselves.

The Bishop asked all members of council to consider pledging to the Transforming Futures appeal. It is his hope that all members of the Clergy and Diocesan Council will take up the pledge to support this initiative financially.

c) Goals of Diocesan Council for the next year

Bishop McMenamie placed three priorities before council.

- 1) Transforming Futures and Stewardship
- 2) Vision Implementation and congregational development
- 3) Understanding conflict as being transformative

The Bishop suggested that Diocesan Council needs to recognize that we need to foster a sense of unity and reconciliation which allows space for learning. He told council that "unity is not uniformity."

Diocesan Council will need to look at its goals for both itself and the Diocese. These goals will need to be:

- a) Specific
- b) Measurable
- c) Achievable
- d) Realistic
- e) Timely

The Diocesan Council broke for lunch at 12:00 and returned at 12:30 pm.
